Dear Treasurer

As in previous years, the Federation is pleased to enclose the forms which can be used to calculate and send the share of the member's subscription due to the Federation and National.

Each WI Member pays a subscription fee for her membership. Subscriptions rates are set by the NFWI Board of Trustees, after consulting the National Council. **WIs now have the flexibility each year to decide whether to either waive the WI share portion of the subscription fee, reduce it slightly, or keep it the same however, please note there can be no reduction in the Federation or National shares.**

We would like to advise all Treasurers that the share owing to Federation and National are due as soon as they have been received by the WI. NFWI and the Charity Commission have issued guidance on the timing of the transmission of fees owed to HCFWI and NFWI. We recommend all treasurers to update their knowledge by referring to MY WI and Charity Commission Guidance.

As last year, we have included a form for each month from March 2026 through to March 2027 inclusive. We recommend that the share of the subscriptions received are remitted to HCFWI on a monthly basis. We believe this makes it easier for a Treasurer to keep track of the amount due. Equally by completing the relevant month's page this will assist with the correct calculation of the amount due.

The membership subscription for 2026-27 is **£54.00**.

Pro-rata subscription for new members in their first year

New members joining the WI from April 2026 for the **first time, or who have not been members of any WI in the past year**, will pay a **pro-rata subscription** depending on the quarter in which they join. The rate per quarter and the distribution are shown in the following table:

New WIs starting in 2026/25

New WIs starting from April 2026 will keep all of the subscriptions paid by their members in the 2026/26 membership year.

Flexibility Policy

WIs can apply the flexibility policy to their 2026/27 subscription. This means they can charge the full amount of the WI portion, reduce their portion, or waive the WI portion of the subscription entirely based on the financial situation of their WI.

Multiple Membership

Multiple members will pay only the WI portion to their non primary WI. If the WI is not utilising the flexibility policy, this will be £27.10. There is no pro-rata rate for multiple membership, and the set fee will remain payable at any time during the year.

Pooling of Fares 2026

Please note that as the Annual Meeting in 2026 will be conducted entirely online, Federations and WIs will not be required to pay Pooling of Fares fees. This will next be applied in 2027 to reflect that the Annual Meeting will be in-person that year.

Pooling of Accommodation 2026

HCFWI retains the per capita accommodation charge in a restricted fund for delegate accommodation for future National Annual meetings requiring one or more overnight stays for delegates. The HCFWI Board of Trustees have reviewed the possible cost of an in-person National Annual meeting in the future and decided to continue to request 20p per member. This charge should be paid from WI funds.

NFWI & Federation subs should all be paid in one sum to 'HCFWI'. We will send NFWI their portion of the subscription and the pooling of fares.
